### Section 3: HAZARDS IDENTIFICATION

#### EMERGENCY OVERVIEW

DANGER. Flammable. Harmful or fatal if swallowed. Aspiration hazard. Causes eye irritation. Avoid inhalation of concentrated vapors. May cause nervous system depression. DO NOT spray product directly on face. Keep away from heat and flame. Contents under pressure.

#### Section 4: FIRST AID MEASURES
