# AERO BUG OFF!

After returning indoors wash treated skin with soap and water.

#### **EMERGENCY OVERVIEW**

### **Specific fire-fighting methods:**

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training.
