Eyes: May cause slight irritation reversible within 24 hours. Product produced conjunctival eye irritation in albino rabbit eyes at 1 hour only. No corneal opacity or iritis was observed.

Skin: Acute dermal LD₅₀ > 2,000 mg/kg (rabbits). Primary skin irritation index = 0.00 (rabbits). Product is not a sensitizer when tested on guinea pigs.

Ingestion: Acute oral toxicity LD₅₀ > 5000 mg/kg (rats).

Inhalation: Not applicable. Formulation is a gel.
